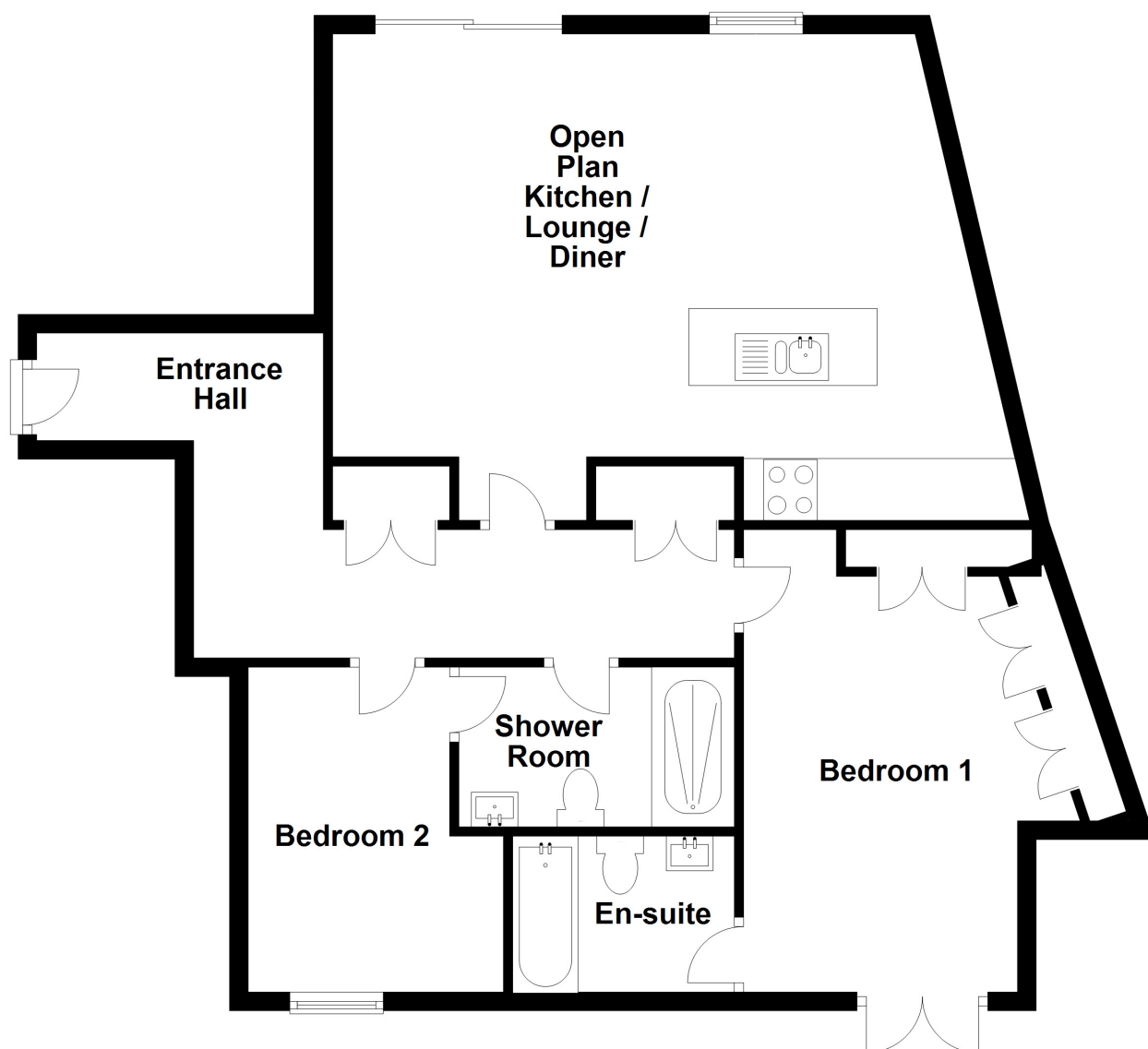




About

Built in 2013 Apartment 1 Clifton Heights is a stunning two bedroom apartment situated on the lower level that looks out onto a spacious communal terrace. The property consists of a high spec open plan living space, comprising a lounge, kitchen with island/ breakfast bar and dining area. There are two good sized bedrooms. The main bedroom has an en suite and plenty of wardrobe space. The second bedroom opens up to a jack and jill shower room. The apartment benefits from secure parking for one car and can be accessed direct from the communal lift. Situated only a short walk from the heart of St Peter Port the property is perfectly positioned for the local amenities and restaurants.
